- Have maintained residence in this district for at least 30 days

Ordinance Review:

'91.02 DOGS AND CATS.

Running at large prohibited. It shall be unlawful for the dog or cat of any person who owns, harbors, or keeps a dog or cat, to run at large. A person, who owns, harbors, or keeps a dog or cat which runs at large shall be guilty of a misdemeanor. Dogs or cats on a leash and accompanied by a responsible person or accompanied by and under the control and direction of a responsible person, so as to be effectively restrained by command as by leash, shall be permitted in streets or on public land unless the city has posted an area with signs reading Dogs or Cats Prohibited.

The City has received several complaints regarding dogs running at large in our community and has decided the following: The first complaint received regarding running at large will be a fine of \$50.00, the second complaint received will be a fine of \$100.00 and the third complaint filed will give the dog owner a \$300 fine and a misdemeanor charge. Please keep your dogs in your own yards at all times. The City will be purchasing a live trap to catch dogs and a kennel to transport dogs to the

Perham pound. All dogs licensed or non-licensed running at large will be brought to the pound.
