The City of Vergas is governed by a City Council comprised of the Mayor and four Council members who meet on the second Tuesday of each month. The City Council is the governing body in matters of the City's policies, problems and needs.

Assisting the City Council in the decision making process is the City Clerk-Treasurer and Utilities Superintendent, who oversees the operation of City departments. Issues and concerns from the general public or City staff are directed to the City Clerk-Treasurer.

Also assisting the City Council are various committees, boards and commissions, which are made up of citizens appointed by the Mayor and confirmed by the Council. These groups are advisory bodies to the Council. These advisory bodies make recommendations to the Council concerning needs based on findings of fact.
