Sealed bids will be received by the City of Vergas, at the City Hall, 111 Main Street, Vergas, MN 56587, until **1:00 PM, March 11, 2019**, at which time they will publically opened and read aloud at the Vergas Event Center, 140 W Linden Street, Vergas, MN 56587 for the furnishing of materials, labor, equipment and skill required for the construction of Street Improvements and Underground Utilities Project and incidental items in and for said City of Vergas, as is more fully described and set forth in the plans and specifications therefore, which are now on file in the office of the KLJ.

Bids shall be upon cash payment on the following estimated quantities and types of work:

Full Depth Reclamation 8” – 9,459 SY, Aggregate Base (CV) Class 5 – 131 CY, Type SP 12.5 Non-wear Course Mix (2,B) – 1,690 TON, Type SP 12.5 Wearing Course Mix (2,B) – 1,472 TON, Remove & Replace Manhole Casting – 12 EA, Adjust Valve Box – 12 EA, Concrete Curb & Gutter Design D418 – 1,259 LF, Mill Bituminous Surface 1.5” – 5,5,366 SY, PVC Watermain – 750 LF, Fire Hydrant – 2 EA, Gate Valve and Box – 5 EA, Water Service – 12 EA, Storm Sewer Pipe – 437 LF, Storm Inlet – 1 EA, Flared End Section – 5 EA, Geotextile Fabric – 3,195 SY, Aggregate Class 5 Surfacing – 998 TON and remaining items in the construction documents.

All bids will be contained in a sealed envelope, as above provided; plainly marked showing that such envelope contains a bid for the above project. All bids are to be submitted on the basis of cash payment for the work and materials. Each bid shall be accompanied by a bid security in a sum equal to five per cent (5%) of the full amount of the bid in accordance with the Instructions to Bidders. The bid security shall be in the form of a Bid Bond, certified check or cashier's check payable to the City of Vergas. The bid security is a guarantee that the bidder, if awarded the contract, will enter into a contract for the work described in the contract documents. A contract shall be awarded on the basis of the low bid submitted by a responsible and responsive bidder for the aggregate sum of all bid items. The successful Bidder will be required to furnish Contract Performance and Payment Bonds in the full amount of the contract.

The Work will be substantial completed on or before **July 3, 2019**, and completed and ready for final payment in accordance with Paragraph 14.07 of the General Conditions on or before **August 2, 2019**.

The Owner reserves the right to reject any and all bids to waive any informality in any bid, to hold all bids for a period not to exceed 60 days from the date of opening bids, and to accept the bid deemed most favorable to the interest of the Owner.

Should the Contractor fail to complete the work within the time required herein or within such extra time as may have been granted by formal extensions of time approved by the Owner, there will be deducted from any amount due the Contractor the sum of \$2,000 per day and every day that the completion of the work is delayed. The Contractor and his surety will be liable for any excess. Such payment will be as and for liquidated damages.
