Mayor's Message

The City Council is going through city ordinances to update and ensure they are reflective of current times and are clear as to regulation intent. There was a public hearing on December 28th to review 3 ordinances with proposed revisions. These will be voted on at the January 10th City Council meeting.

- Change to ordinance regarding snowmobiles. The ordinance
 was simplified to address designated routes within the City of
 Vergas and easement requirement when traveling upon or
 across private property. The detailed Minnesota
 requirements were removed and the ordinance now refers to
 license requirements and operator qualifications are in
 accordance with Minnesota Statutes.
- 2. Change to ordinance regarding Dogs and Cats. There was a component of the current ordinance that noted cats shall be included in all provisions of ordinance, yet there were a number of other components where only dog is noted. After review of other city ordinances, city received complaints, and history of the Vergas ordinance, it was proposed by the council that the ordinance be all inclusive of cats and dogs, to include running-at-large, licensing, proof of vaccination and impounding.
- 3. Change to Declaration of Snow Emergency regarding Prohibited Parking. The current ordinance had police chief/officer noted, which do not exist in Vergas. The ordinance was also clarified when there is snow accumulation requiring need for removal a snow emergency may be declared so no motor vehicle is parked on any street. This will ensure snow can be removed by county and city staff and people can safely drive and have access to get onto sidewalks. If no emergency is declared, motor vehicles still need to be moved until the street is cleared on both sides. The communication process for this ordinance when a snow emergency is declared is posting on the City Face Book page and notices posted at the city businesses.

Ordinance updates and improvements will continue in 2023 to ensure the city has relevant, valid, and accurate regulations and will solicit public input via public hearings. This is your opportunity to ask questions and offer feedback.

Happy New Year! A new Council will be sworn in at the January meeting and we look forward to another successful year in 2023 in serving the City of Vergas.

<u>Proper Disposal of Fats, Oils</u> <u>and Grease</u>

Fats, oils and grease (also known as F.O.G.) are as bad for sewer pipes as they are for our arteries and waistlines. F.O.G. clogs sewer pipes and causes blockages that result in costly sewer backups and overflows.

These sewer backups and overflows can cause health hazards, damage home interiors and threaten the environment.

Most of us know grease as the byproduct of cooking.

Grease is found in such things as:

Meat fats, Cooking oil, Shortening, Butter and margarine,
Food scraps, Sauces, Dairy products, Baking goods.
Too often, grease is washed into the plumbing system,
usually through the kitchen sink. Grease sticks to the
insides of sewer pipes both on your property and in the
streets. Over time, the grease can build up and block the
entire pipe. Home garbage disposals do not keep F.O.G.
out of the plumbing system. These units only shred solid
material into smaller pieces and do not prevent F.O.G
from going down the drain.

'93.03 MATERIALS ON STREET OR SIDEWALK.

(A) No person shall encumber any street, sidewalk, or right-of-way. No owner, occupant, or person having the care of any building or lot of land, bordering on any street, sidewalk, or right-of-way shall permit it to be encumbered with barrels, boxes, cans, articles, or substances of any kind, so as to interfere with the free and unobstructed use thereof.

(B) Except for the actions of the city employees and contractors carrying out their duties, no person shall:

(1) Obstruct any street or sidewalk by depositing snow or ice thereon; Penalty, see ' 10.99
