With spring in the horizon, hoping soon, you will note changes this year with the City Yard Waste site.

The City yard waste site has been a challenge and the Council would like to more closely review and get a better handle on what additional actions may be needed to address the issues the city is experiencing. For non-residents the permit fee to use the yard waste site went up to \$60. For city residents the cost is free, but the Council recommended residents have a permit (different color) so the city can better track who is actually using the site. Additionally, outreach is occurring with the townships to get feedback regarding non-resident use.

City of Vergas residents stop in at the city office and get your yard waste permit and feel free to provide any additional thoughts and input as we work to better understand the yard waste site needs.

Special shout out to our city crew who have responded to an especially brutal winter with the city snow removal needs. We appreciate the added time and efforts to keep the City streets open and safe!

Driveway sealer, Drain cleaners, Furniture polish, Fuels: gasoline, kerosene, etc.,
Fertilizer, Fluorescent lightbulbs (10 per household), Herbicides, Insecticides,
